The 100 Club of Arizona is a 501(c)3 organization providing support to municipal, county, tribal, and state law enforcement agencies, public safety officers, correctional, parole & probation officers, firefighters, and their families through various programs and benefits. Through these efforts, we have provided more than \$5.9 million to over 1,200 families since initiation in 1968.



## *Our Mission:*

*To provide immediate financial assistance to families of public safety officers and firefighters who are seriously injured or killed in the line of duty, and to provide resources to enhance their safety and welfare.*



## OUR PROGRAMS & BENEFITS

**Benefits** provide financial assistance to the families of public safety officers and firefighters upon death or serious injury, and are extended to officers and firefighters when called to active duty military. Direct family benefits are currently \$15,000 for line of duty death, \$5,000 for non-line of duty death, and up to \$18,000 for line of duty injury cases.

**Safety Enhancement Stipend (SES)** - This program awards money to public safety agencies to purchase equipment that directly enhances the safety of their officers or firefighters. The SES Program has awarded over \$880,000 to more than 100 applicants statewide. Applications for SES funds are reviewed quarterly and awarded based on need, demand and available funds.

**Scholarships** - The 100 Club Scholarship Program is available for immediate family members of public safety officers and firefighters that wish to continue their education beyond high school. Together, over 80 students have received scholarships exceeding \$400,000.

**Professional Advisory Team (PAT)** - PAT is a group of dedicated professionals that provide families, without charge or obligation, guidance in addressing financial, legal, tax, estate matters, educational needs, possible job training, grief and stress counseling in the aftermath of a tragedy. Countless hours have been donated by these professionals and over \$400,000 has been given to support public safety families with these special needs.

**H.E.R.O.S.** - Helping Emergency Response Officers and Survivors is a program that allows the 100 Club and its supporters to coordinate available resources with needs of public safety families and provide financial assistance to those in need.

**Peer 100** - The Peer 100 Program addresses the wellness challenges in the public safety profession for officers/firefighters/families and emphasizes support, training, resources, referrals and services. These opportunities are available when agencies are not able to provide resources for the welfare of their officers/firefighters.

## FREQUENTLY ASKED QUESTIONS

### **How long has the 100 Club of Arizona been established?**

The 100 Club was organized in 1965 and incorporated as a nonprofit in 1968.

### **Where does the name "100 Club" come from?**

The 100 Club of Arizona is patterned after the 100 Club of Detroit, Michigan, which began in 1952. When a young officer was killed in the line-of-duty a local car dealer, William M. Packer, contacted 100 of his friends and asked them to donate \$100 to a fund for the fallen officer's widow and unborn child. Packer received 100 percent response and was able to pay off the mortgage and provide an education fund for the unborn child.



### **What level of support has been provided in the past?**

The 100 Club of Arizona has provided more than \$5.6 million to more than 1,200 agencies, officers, firefighters, and families of public safety. In 2010, just over \$700k was provided to 198 public safety families and agencies.

### **Where does the money used to assist public safety officers and firefighters come from?**

Money is raised through yearly membership dues, charitable campaigns, endowments, and donations from those that support our mission. We do not use telemarketing fundraisers.

### **Does the 100 Club receive funds through United Way or CFC/SECC/ECAP?**

Yes, we do receive donations through United Way/CFC/SECC/ECAP. Our campaign codes: SECC - ST606, Valley of the Sun United Way - 8110, Maricopa County Combined Federal Campaign - 42229, Arizona Combined Federal Campaign - 42229, Pima ECAP - 2184. ### **How much of my donation, if any, is tax deductible?**

The 100 Club of Arizona is exempt from federal income taxes under Section 501(C)(3) of the Internal Revenue Code, therefore your gift is tax-deductible to the full extent provided by law. The 100 Club of Arizona is a nonprofit charity operating since 1968. Our federal tax identification number is 23-7172077. You should consult your financial planner or tax advisor to determine the exact tax advantages of any gift you are considering.

### **How much of what I donate actually benefits the families of public safety?**

Over the past three years, the 100 Club of Arizona has spent an average of 83 percent of total revenue on current needs. That means that our fundraising and administration costs over that period averaged 17 percent. The 100 Club of Arizona strives to never go over 20 percent for all administrative and fundraising costs.

### **Do public safety officers or firefighters have to be members of the 100 Club of Arizona in order to receive a benefit?**

No, it is not required for public safety officers, firefighters, their families or the agencies they work for to be members of the 100 Club of Arizona to receive a benefit from our organization.
